- 3. Report of the Directors:
 - a. President (Dr. Don Milliken)
 - COVID-19 Response: the work we are doing could not be the same as we were doing before; we had to do things differently. We have been lucky here on the Island but epidemics occur around the world all the time. It highlighted our lack of surge capacity and other gaps in the system. Physicians were compensated for parts of their time, but not everything was covered even with our funding. During this COVID crisis, we supported physicians whether they paid their MSA dues or not.
 - Projects: work has been documented in our Storybook. Under the working group, led by John Galbraith, 175 projects have been approved and completed. Not every project is a success, but they have been worth trying and learning has happened with every project
 - Advocacy for Individuals and Groups: two components, we are supposed to be notified of any disciplinary action and consult with our members about their rights. In addition, when meetings occur with administration, we can attend as a "friendly face" in the room. Thanks to Dr. Fred Voon, Dr. Catherine Jenkins and Dr. Daisy Dulay on leading this work.
 - iHealth: held first meeting to discuss the process in South Island and the plan for moving forward; minutes and video from this meeting will be available
 - Social and Wellness Activities: under Dr. Daisy Dulay's lead. We were unable
 to run most events this year (Welcome & Thank You, annual BBQ) but
 wellness has stayed at the forefront (group walks, Mindful Mondays). Daisy
 is our provincial lead for addressing psychological and physical safety in the
 MOU

- Thanks: reminder to say thanks to our colleagues and the staff we work with. This is essential to preventing burnout. Big thanks to Dr. Parvinder Birdi, who is stepping down as the MSA Vice President, and MSA staff, especially Erica Kjekstad.
- b. Director at Large E.H.R. (Dr. Catherine Jenkins)
 - Asked Island Health to put iHealth on hold due to COVID and they were supportive; it is part of the Memorandum of Understanding that "Health Authorities will actively engage with physicians before and throughout EHR implementation by seeking physicians' feedback and input into planning, design and implementation processes"
 - Provincial Funding: implementation in three year window, majority of funding for training and medical staff support in 2nd and 3rd year
 - Technical Computer System: platform has been updated, different from what Nanaimo had; closer to that used on Mainland. Benefit of improvements from Nanaimo and other sites that have gone live
 - Training: recognition that needs to be more training and support, recognition that physicians need to be compensated for their time, details of what constitutes adequate training not yet negotiated
 - Workload/Occupancy Rates: Cerner defined 85% occupancy as goal for implementation, difficult to achieve; possible role of supernumeraries to reduce workload
 - Culture: we can shift the culture; we have the potential to make this system work and make it work better
 - Provide meaningful input: Data driven, realistic goals, recognize that this is happening, budgetary and resource limitations
 - Ensure broad engagement
 - Recognize the best time to intervene is before implementation
