3. Report of the Directors:

- a. Co-President (Dr. Catherine Jenkins)
 - It's been a tough year and it is not over yet
 - Fear of COVID is receding, some issues uncovered by COVID, such as workforce shortages remain
 - Hopeful new PMA will help; will take years to make significant shifts in manpower
 - Issues are more than MSA or Health Authority can solve, but want to continue to play a role in trying to ease some of the stress
 - MSA addressing these issues through three main themes:

Medical Staff Support:

- Patient care is better when medical staff feel supported and part of a community; role of Wellness and Social committee - have activities to bring physicians together (Zoom lectures, Mindful Mondays, Walking group, Summer picnics)
- Individual advocacy for physicians having difficulty navigating through Island Health – focus has mostly been on discipline; also helping with onboarding/connecting physicians who need help with resources

System Improvement:

- Facility Engagement Initiative 'Engagement and Quality Improvement Grants' (\$10,000); community is built by working and problem solving together, taking chances
- Focus on making it possible for members who don't have QI experience to become involved and on supporting first time applicants
- Testament to what can be done with minimal resources

Advocacy:

- Improving relationship between front-line medical staff and Health Authority; multi-year journey
- Example: IHealth started with a great deal of trepidation; trying to establish we want the system to succeed; greater input into timelines
- Made progress to establish that consulting medical staff is a valuable tool to make the system work better
- Moving towards more gradual launch staggering CPOE at VGH and RJH; possibly allowing early adoption of some aspects of CPOE – e.g. Medical Imaging ordering in ER
- Worked to create Island Wide trust with other MSAs and identify common goals; three Island wide initiatives:
 - Improving Transparency and Communications from and with Island Health
 - Issues heavily impacting Central and North Island, and affect us indirectly: Transportation, Cardiovascular services above Malahat
 - Recognize if we are serious about Reconciliation, need to help areas where 80% of First Nations live
